- 3. Electronic Bidding document is available online and can be downloaded on or before office hours on 2078/01/05 (April 18,2021) from PPMO's website http://www.bolpatra.gov.np/egp. The Bidders have to download the necessary part of bidding documents, prepare their bid and submit their electronic bids as specified in the Instructions to Bidders. The Bidder shall be required to deposit the non-refundable fee in following account as specified below for bid document and electronic scanned copy (pdf format) of the Bank deposit voucher shall also be submitted along with the electronic bid files.

- 5. The bids will be opened in the presence of Bidders representatives who choose to attend at 2078/01/05 (April 18, 2021), 14:00 hours at the office of Naukunda Rural Municipality, Saramthali, Rasuwa.
- 6. Bids must be valid for a period of 45 days counting from the day of bid opening and must be accompanied by bid security amounting as stated below deposited at \$104010000002 (Ga.3 Dharauti Khata Naukunda.) on behalf of Naukunda Rural Municipality at Global IME bank., Naukunda Branch, Rasuwa or bid bond authorized from a recognized commercial bank of Nepal, which shall be valid for minimum 30 days beyond the bid validity period.
- 7. If the last date of purchasing and/or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
